URGENT DRUG WITHDRAWAL

August 6, 2021

This is to inform you that Grifols Therapeutics is initiating a voluntary withdrawal of Gamunex® -C 10% lots, as detailed below.

As a precautionary measure, this voluntary withdrawal is being conducted due to risk of higher rates of allergic/hypersensitivity type reactions, some of which may be medically significant. Hypersensitivity and anaphylactic/anaphylactoid reactions are a known risk with IVIG products.

This withdrawal is being conducted with the knowledge of the U.S. Food and Drug Administration, Center for Biologics Evaluation and Research.
